Parental Consent and Waiver of Liability - Assumption of Risk – Indemnity Agreement DIW 2010 Summer Program

I, the undersigned parent or legal guardian of (Student Name) _____ (herein referred to as my "Child"), consent to have my Child be allowed to arrive at and depart The Dance Institute of Washington (herein referred to as "the Premises" or "DIW") without an authorized guardian. This consent agreement shall remain in effect until DIW receives written notice of the cancellation of this consent, or until the conclusion of the DIW 2010 Summer Program. In return for my Child being permitted to arrive and depart the premises without an authorized guardian, I make the following promises and warrant as to the truth of the following facts:

1. I agree that DIW assumes no responsibility for the supervision of my Child before the hour of 8:45AM and after the hour of 4:00PM.
2. I hereby waive and release any right I, my heirs, distributees, guardians, legal representatives and assigns may have or acquire to make a claim against, sue, attach the property of, or prosecute The Dance Institute of Washington or any of its members, governors, officers, agents, instructors, and affiliated organizations (herein referred to as "the Releasees") for monetary damages caused by injury to my Child or damage to the property of my Child or myself arising from my Child's vacation of the premises before the hour of 8:45AM and after the hour of 4:00PM, whether or not the injury or damage results from the negligence or other action of any of the Releasees.
3. I accept any and all risks to my child of injury, death, and property damage arising from vacation of the premises before the hour of 8:45PM and after the hour of 4:00PM, whether or not caused by the negligence or other action of any of the Releasees.
4. I agree to indemnify and hold harmless the Releasees from any loss, liability, damage or cost, including reasonable attorneys fees, they may incur due to my Child's vacation of the premises, whether or not such loss, liability, damage or cost results from the negligence or other action of any of the Releasees.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THE AGREEMENT INCLUDES A WAIVER OF LIABILITY, AN ASSUMPTION OF RISK, AND AN AGREEMENT BY ME TO INDEMNIFY THE RELEASEES, AND I SIGN IT OF MY OWN FREE WILL.
